Notification of Disclosable Pecuniary Interests and Other Registerable Interests for inclusion in the Register of Commissioners' Interests

Government Guidance on Statutory Interventions states that Local Authorities should make arrangements for Commissioners to register and disclose any Disclosable Pecuniary Interests and Other Registerable Interests through the completion of a Register of Interests in support of transparency and good governance.

Your Register of Interests will be retained by the Council for the period during which you are a Commissioner, and for 3 years after you cease to be a Commissioner. Your Register of Interests will be published on the Council's website during the period for which you are a Commissioner. Interests declared during the decision making process will be recorded in the record of that decision (Minutes of meetings or formal decision making forms). These records will be published on the Council's website (unless exempt) and will be kept in perpetuity as a record of decision-making by the Council. It is your responsibility to ensure that the information provided on your Register of Interests is accurate and kept up-to-date.

- (c) any body of which they are a member that is a private club or society, such as the Freemasons, a recreational club, working men's club or private investment club.
