## myHealth-E

myHealth-E (MHE) is an NHS digital health monitoring system. It is designed to empower families working with behavioural and mental health conditions and aims to enhance their experiences of using the Behavioural Emotional Mental Health pathway (BEMH) by making it easier to complete questionnaires on symptoms, gain access to relevant information of their child's progress and access clinical research and trials.

Nottingham City Council's Behavioural & Emotional Health Team (BEHT) is using myHealth-E to support their work with young people and their families. Using myHealth-E will support children and young people with neurodevelopmental conditions and their caregivers between clinic visits and help improve the quality of data available for monitoring treatment effectiveness of Behavioural Emotional & Mental Health services.

Nottingham City Council's Behavioural & Emotional Health Team (BEHT) will work the individual young people on the basis that it is necessary for the performance of a task carried out in the public interest. BEHT staff will directly consult with and inform young people and their parents/carers about the BEHT registration process and the role that myHealth-E plays in it. One of the benefits of myHealth-E is that it offers parents/carers an opportunity to register their interest in involvement in various research projects, including an online parenting intervention trial.

Individuals may still access BEHT support without having their data entered into myHealth-E.

You are not obliged, either by statute or by contract, to provide the information that is requested here. The information provided by you may also be used for the purpose of any other function carried out by the Council. - A right in certain circumstances to request portability of your data to another provider

- A right regarding automated decision-making including profiling
