We seek a full variation of premises licence no. 233133 in three respects:

Addition of off sales of alcohol

Amendment of the premises plan to include the external pavement seating area

Removal and replacement of condition 14

Reason for variation / details of proposed changes

Off Sales

Our current licence permits on sales only. We wish to add off sales of alcohol as we now have a pavement license and wish to offer the same experience to our guests who'll sit outside. KINU operates a single bar inside the premises. Customers seated in the external pavement seating area will place their order with a member of staff at the table. That member of staff will return to the bar inside, where the alcohol will be prepared and will then bring the drink to the customer outside. We understand this constitutes an off sale under the Licensing Act 2003.

All alcohol in the external area will be served by table service only to seated customers. Customers will not be permitted to remove alcohol from the premises or the licensed external area.

Premises Plan

We wish to amend the premises plan to include the external pavement seating area fronting 12 Low Pavement. A Pavement Licence was granted by Nottingham City Council on 19 May 2026 covering an area 8.6 metres wide by 2.7 metres deep. An updated plan is enclosed.

Condition 14 — Removal and Replacement

We wish to remove condition 14 and replace it with the following:

Persons carrying open vessels containing alcohol must not be admitted to the premises at any time, except when using the external seating area authorised to be used under a pavement licence.

The external seating area will operate as an ancillary area to the main restaurant. Alcohol served externally will be to seated customers only and ancillary to a table meal. The premises will operate CCTV, Challenge 25, staff training, refusals and incident logs, and regular staff supervision of the external area to promote the licensing objectives and minimise nuisance and disorder.

b) The prevention of crime and disorder

A digital CCTV system covering the internal and external areas of the premises will be maintained and operated at all times whilst the premises are open to the public. Recordings shall be retained for a minimum of 31 days and made available to Police or authorised officers upon request.

The premises shall operate a Challenge 25 policy. Staff will receive training regarding the sale of alcohol, prevention of underage sales and refusal of service to intoxicated persons.

Alcohol served in the external area shall be ancillary to a table meal and consumed by seated customers only. No vertical drinking will be permitted.

A refusals log and incident log will be maintained at the premises.

c) Public safety

The external seating area will be regularly monitored by staff to ensure customer safety and appropriate conduct.

Tables and chairs will be arranged and managed to maintain safe pedestrian access at all times.

The premises will maintain appropriate fire safety procedures, staff training and first aid provisions.

Glassware and waste will be regularly cleared from the external area to maintain a safe environment for customers and passers-by.

d) The prevention of public nuisance

The external area will operate as part of the restaurant only and will not function as a standalone drinking area.

Customers using the external seating area will be monitored by staff and reminded to respect neighbouring residents and businesses, particularly when leaving the premises.

Management reserve the right to refuse or cease service in the external area where customer behaviour may cause nuisance or disturbance.

The premises will operate a dispersal policy to encourage customers to leave the area quietly and respectfully.

e) The protection of children from harm

The premises shall operate a Challenge 25 policy and acceptable identification will be required from any person appearing under the age of 25.

Staff will receive regular training regarding underage sales prevention and licensing responsibilities.

Children will remain under the supervision of a responsible adult whilst using the premises and external seating area.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.

 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

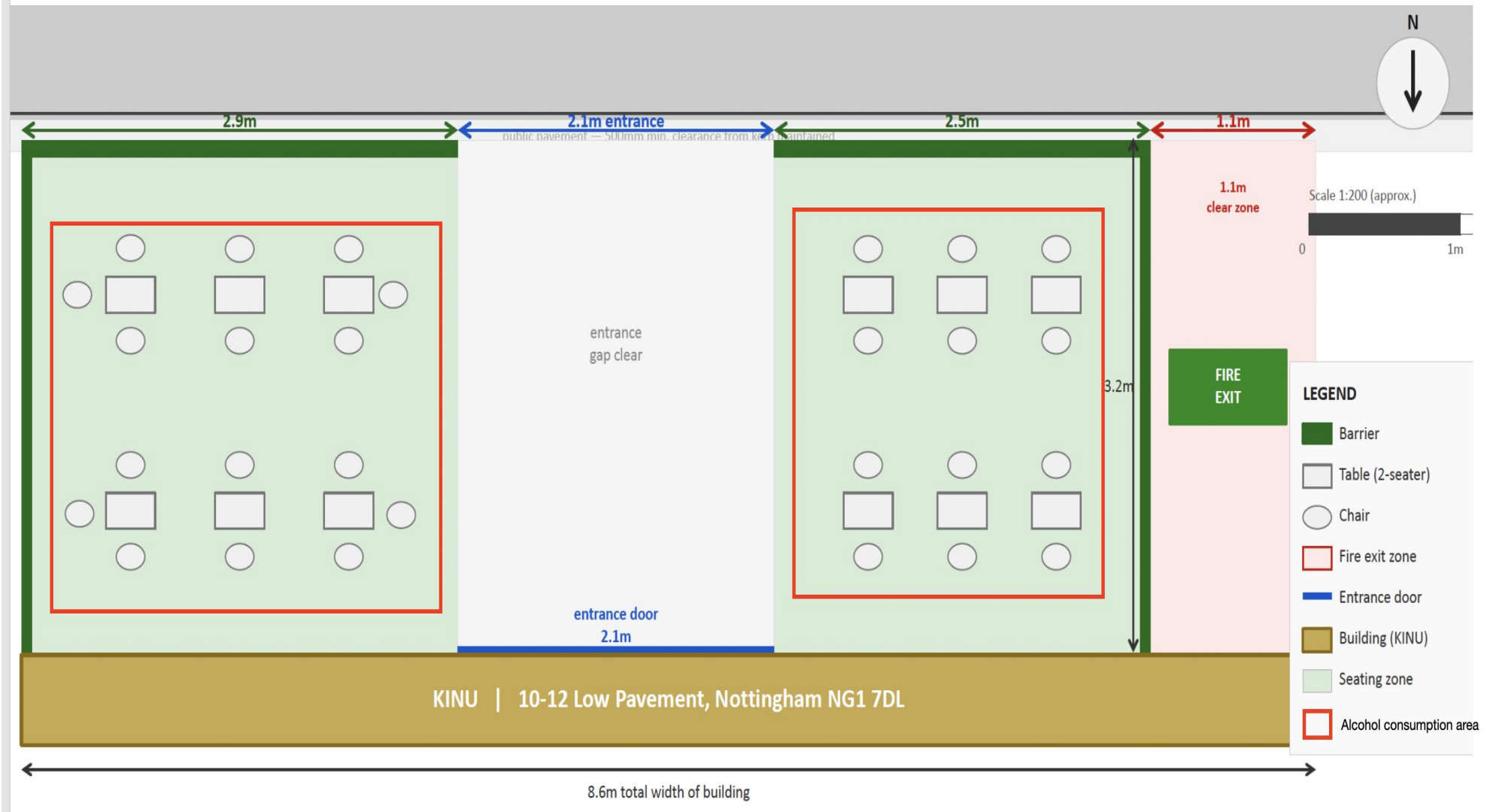
