Supply of Alcohol - Operating Schedule

1. On-Sales and Seating Alcohol shall be sold for consumption on the premises and within the external seating area as identified on the submitted plan. All such sales shall be via waiter/waitress service to customers seated at tables or at the bar area.

2. External Area Restrictions The use of the external seating area for the consumption of alcohol shall cease at 23:00 daily. An exception is made for occasions where the area is formally authorised for specific events (such as Pride), subject to all necessary highway permissions being in force and appropriate management supervision.

3. The Restaurant Condition The premises shall operate primarily as a restaurant. With the exception of a maximum of 20 non-dining persons at any one time, alcohol shall only be sold to persons taking a substantial table meal and for consumption as an ancillary to that meal.

4. Off-Sales The sale of alcohol for consumption off the premises shall be strictly restricted to:

- Alcohol supplied as an accompaniment to a takeaway meal collected in person by the customer at the premises.
- The removal of a partially consumed, resealed bottle of wine that was purchased in conjunction with a substantial table meal.
- For the avoidance of doubt, the premises shall not provide a delivery service for alcohol. All sales of alcohol for consumption off the premises must involve a face-to-face transaction at the premises where the "Challenge 25" ID check can be physically conducted by staff.

a) General – all four licensing objectives (b,c,d,e)

1. Management and Supervision: The premises shall be maintained as a responsible and professionally managed restaurant. The Premises License Holder (PLH) will ensure that there is effective supervision of the premises at all times to ensure the safety of customers and the prevention of public nuisance.
2. Staff Training and Documentation: All staff involved in the sale of alcohol shall receive comprehensive training regarding the licensing objectives, including "Challenge 25" protocols and conflict management.
 - o This training shall be documented in a dedicated training log.
 - o Training records shall be signed and dated by both the employee and the DPS and made available for inspection by the Police or an authorised officer.
 - o Refresher training shall be conducted and recorded at least every six months.
3. Incident Recording: An incident log shall be maintained and kept on the premises to record all crimes, complaints, incidents of disorder, or visits by authorities.
4. Pattern Identification: Management shall conduct a monthly review of the incident log to identify repeat incidents or emerging patterns, sharing this data with authorities upon reasonable request.

b) The prevention of crime and disorder

1. Digital CCTV System: A comprehensive digital CCTV system shall be installed and maintained. All entry/exit points, the lower ground floor and ground floor service areas will be covered to "evidential quality." Recordings shall be stored for 31 days with correct time/date stamping. A staff member capable of operating the system shall be on-site at all times the premises are open.
2. Incident and Refusals Logs: The premises shall maintain an Incident Log and a Refusals Log (bound book or electronic). These shall be checked and signed off by the DPS at least monthly.
3. Staff Training and Intoxication Policy: All staff shall be trained in identifying signs of intoxication, preventing "proxy sales," and conflict de-escalation.
4. Operational Controls:
 - o Occupancy: Management shall enforce sensible occupancy limits to ensure customer safety.
 - o Off-Sales: Alcohol sold for consumption off the premises shall be ancillary to a food order and will not be promoted as a standalone activity.
 - o Entry Policy: Management reserves the right to refuse entry to any person showing signs of intoxication or aggressive behaviour.
5. Liaison: The management shall maintain a proactive rapport with local Police and participate in local "Pub Watch" schemes if active.

c) Public safety

1. Emergency Procedures & Fire Safety: All staff shall be fully trained in the premises' emergency procedures and fire safety policy.
 - o Specific management controls shall be in place to ensure the safe evacuation of the lower ground floor area.
 - o Regular fire drills and equipment checks shall be conducted and documented in a dedicated fire safety logbook, available for inspection upon request.
2. Health & Safety Policy: A comprehensive, written Health & Safety policy shall be maintained and reviewed annually.
 - o Free potable drinking water shall be made available to customers at all times that alcohol is being served.

3. Glassware and Spillages: Staff shall be tasked with the prompt removal of all empty glassware and bottles from both internal and external seating areas to prevent hazards.
 - o All spillages shall be identified and cleared immediately; wet floor signage shall be utilized where necessary.
4. Occupancy and Supervision: Capacity limits, as determined by the fire risk assessment, shall be strictly adhered to.
 - o Sufficient staffing levels and managerial supervision shall be maintained during all hours of operation to ensure the safety of patrons and staff.
5. Safe Collection and Food Delivery:
 - o All alcohol sold for takeaway (off-sales) shall be securely packaged in sealed containers and must be collected in person by the customer at the premises.
 - o Alcohol shall not be provided for delivery. Third-party couriers (such as Deliveroo or Uber Eats) shall be strictly prohibited from carrying alcohol from the premises.
 - o Food-only delivery orders shall be packaged securely to prevent tampering during transit.
 - o A "Challenge 25" ID verification shall be conducted face-to-face by staff at the premises for any collection order containing alcohol.
6. Drugs and Anti-Social Behaviour: The premises shall operate a zero-tolerance policy towards illegal drugs and anti-social behaviour.

d) The prevention of public nuisance

1. Waste and Delivery Management: No bottles or glass shall be placed in external bins between 21:00 and 09:00 (10:00 on weekends). No refuse collections or deliveries shall take place during these same hours.
2. Noise Control: Noise from regulated entertainment shall be monitored to ensure no nuisance to residents. All external doors and windows shall be kept closed after 22:00, except for access. No music shall be broadcast to the external seating area.
3. External Seating: Consumption of food or drink in the external seating area shall cease at 23:00 daily. After this time, the area shall be cleared of patrons. Alcohol consumption outside is strictly limited to this authorised area.
4. Dispersal Policy: Clear notices shall be displayed asking customers to leave quietly. A formal Dispersal Policy shall be implemented, with staff proactively managing the departure of customers between 23:00 and 02:30 to ensure they move away from the vicinity quickly.
5. Litter: The area immediately surrounding the premises shall be kept clear of litter associated with the business.
6. Noise management: All windows and doors shall be kept closed after 23:00, except for the immediate entrance and egress of customers, to minimise the breakout of amplified music. Management shall conduct 'boundary checks' at the perimeter of the building during live performances to ensure noise levels are reasonable.
7. Noise from recorded or live music shall not be audible at the façade of the nearest noise-sensitive premises (neighbours) after 23:00
8. During the final 30 minutes of opening (the 02:00-02:30 wind down) the volume of recorded music shall be significantly reduced to a background level to encourage a quiet and orderly dispersal of customers.

e) The protection of children from harm

- Challenge 25: The premises shall operate a "Challenge 25" policy. Anyone appearing under 25 must produce approved photographic ID (Passport, Driving Licence, or PASS card). Signage shall be prominently displayed.
- Accompanied Access: Persons under 18 must be accompanied by a responsible adult if they are to remain on the premises after 21:00.
- Proxy Sales: Staff shall be trained specifically to identify and refuse "proxy sales" (adults buying for minors).
- Refusals Log: All under-age-related refusals shall be recorded, including date, time, and staff name, and reviewed monthly by the DPS.
- Supervision: Management shall ensure sufficient staffing to monitor the lower ground floor and external seating to ensure alcohol is not passed to minors.
- CCTV shall be used to monitor the premises (including the external area) to ensure the safety of children and to provide evidential footage in the event of any suspected illegal activity involving minors.

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

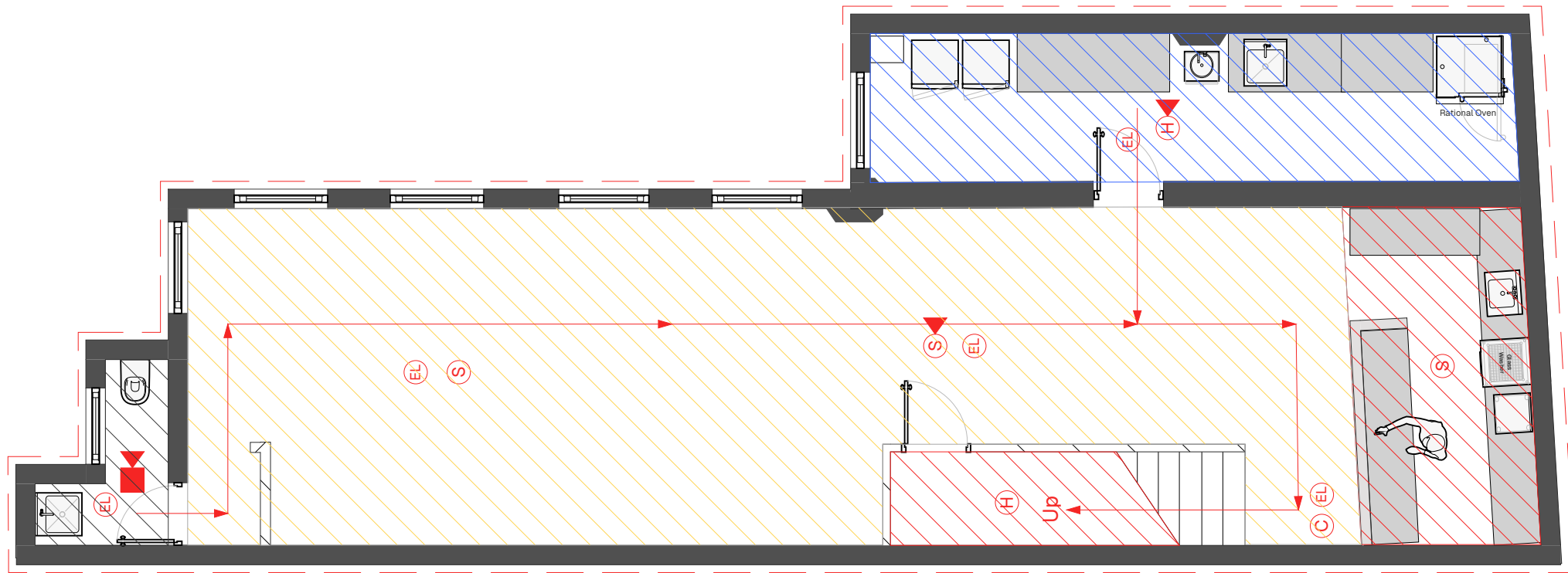

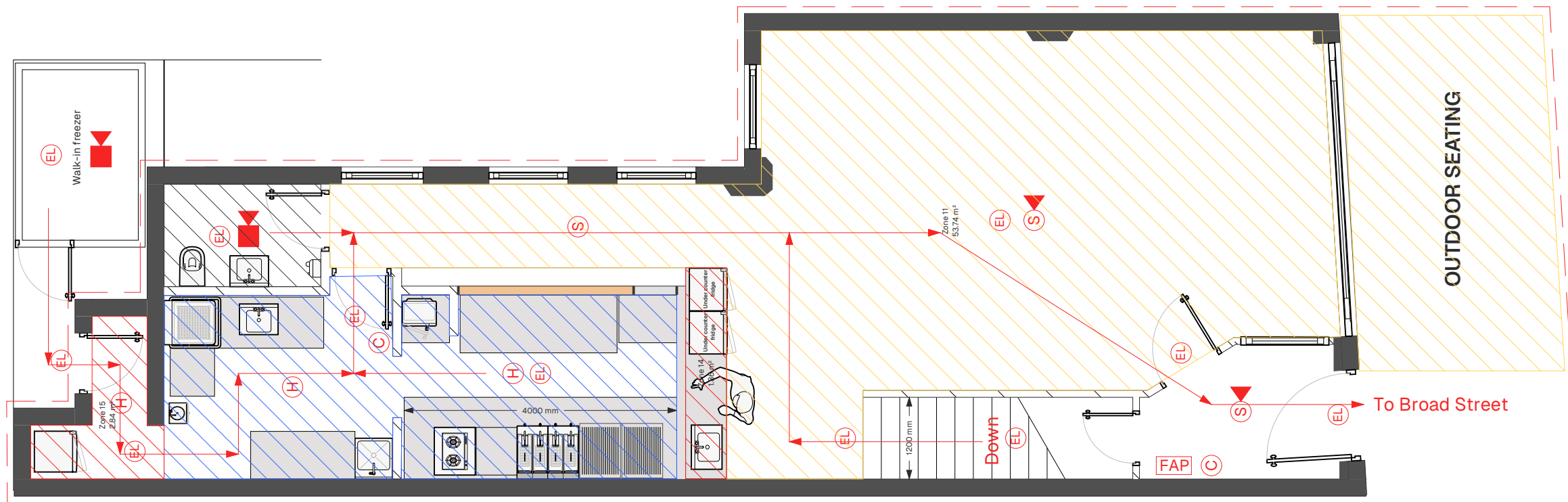
