Describe the steps you intend to take to promote the four licensing objectives:

### **a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)**

All of our venues undergo a risk assessment prior to opening, and these are reviewed annually to ensure that all operations are safe and healthy. Food halls are family venues and appeal to a wide range of demographic. We take licensing seriously and will seek to specifically engage with the areas as detailed below. All our staff go through a comprehensive staff train program (provided by CPL) to ensure that they are aware and resourced for safe operations. Within the food hall we also work with a number of independent food partners, we work alongside them to ensure that they also remain compliant in their operations. Over all we promote a safe and respectful environment for guest to operate it.

### **b) The prevention of crime and disorder**

CCTV will be installed on site above entrance and exit doors and outside. CCTV will be capable of recording heads and shoulders of all entering the premises. Cameras will also capture floor areas, and will provide quality colour footage linked with time and date. All recordings will be stored in a secure area/cabinet, be regularly maintained and stored on a devise that can be made available to local police when needed. Recordings will be kept for 28 days in compliance with Nottinghamshire Police. Staff will be trained on this system so that when necessary we can provide immediate access. Notices will placed within the unit to inform guests of CCTV. We would also be interested in exploring further links with the Nottingham Crime Reduction Partnership in order to partner around anti social behavior prevention. At the weekends we have SIA registered professional security on the door at at other busy times.

### **c) Public safety**

Appropriate fire safety procedures have been put in place including relevant fire extinguishers, fire blankets, internally illuminated fire exit signs, smoke detectors, and emergency lighting are all fitted within the venue. All emergency exits shall be kept free from obstruction at all times. We employ a health and safety consultant who works with us to produce a risk assessment and a fire risk assessment for our sites. These are reviewed every year and all sraff are trained in accordance with these. We work with EHO to ensure all cooking and food preparation is done according to the Food and Hygiene Standards and this is reviewed each week with all food partners. All Bar Staff are trained in challenge 25 procedures and in the Ask for Angela scheme.

### **d) The prevention of public nuisance**

All customers will be asked to leave quietly. we will operate within the constraints of our lease agreement to ensure that we do not cause a nuisance to any local residents. Food halls are family orientated venues and whilst we provide food and small event activations into the evening, guest typically leave the venue by 22:30 to return home or to move on to other late night venues. Our on site team will monitor this, especially any outside areas to ensure that guests do not create a nuisance

### **e) The protection of children from harm**



The licensee and staff will ask persons who appear to be under the age of 25 for photographic ID such as proof of age cards, the Connexions Card and Citizen Card, photographic driving licence or passport, an official identity card issued by HM Forces or by an EU country, bearing the photograph and date of birth of bearer. All staff will be trained for underage sales prevention. Under 12's to always to be accompanied by an adult when inside our food hall. All events hosted within our venue are family friendly and all music is likewise carefully chosen to remove any adult only lyrics or themes

    - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
  - Recorded Music: no licence permission is required for:



- any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
  - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
  - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
    - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
    - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
    - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
    - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
3. Where taking place in a building or other structure please tick as appropriate (indoors may include a tent).
  4. For example the type of activity to be authorised, if not already stated, and give relevant further details, for example (but not exclusively) whether or not music will be amplified or unamplified.
  5. For example (but not exclusively), where the activity will occur on additional days during the summer months.
  6. For example (but not exclusively), where you wish the activity to go on longer on a particular day e.g. Christmas Eve.
  7. Please give timings in 24 hour clock (e.g. 16.00) and only give details for the days of the week when you intend the premises to be used for the activity.
  8. If you wish people to be able to consume alcohol on the premises, please tick 'on the premises'. If you wish people to be able to purchase alcohol to consume away from the premises, please tick 'off the premises'. If you wish people to be able to do both, please tick 'both'.
  9. Please give information about anything intended to occur at the premises or ancillary to the use of the premises which may give rise to concern in respect of children, regardless of whether you intend children to have access to the premises, for example (but not exclusively) nudity or semi-nudity, films for restricted age groups or the presence of gaming machines.
  10. Please list here steps you will take to promote all four licensing objectives together.
  11. The application form must be signed.



12. An applicant's agent (for example solicitor) may sign the form on their behalf provided that they have actual authority to do so.
13. Where there is more than one applicant, each of the applicants or their respective agent must sign the application form.
14. This is the address which we shall use to correspond with you about this application.

#### **15. Right to work/immigration status**

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways:

- 1) by providing with this application copies or scanned copies of the documents which an applicant may provide to demonstrate their entitlement to work in the UK (which does not need to be certified) that are published on GOV.UK and in guidance issued under section 182 of the Licensing Act 2003
- 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below)

#### **Home Office online right to work checking service**

As an alternative to providing a copy of the documents, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copy documents as set out above.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the home office. Your licence application will not be determined until you have complied with this guidance.

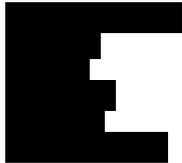

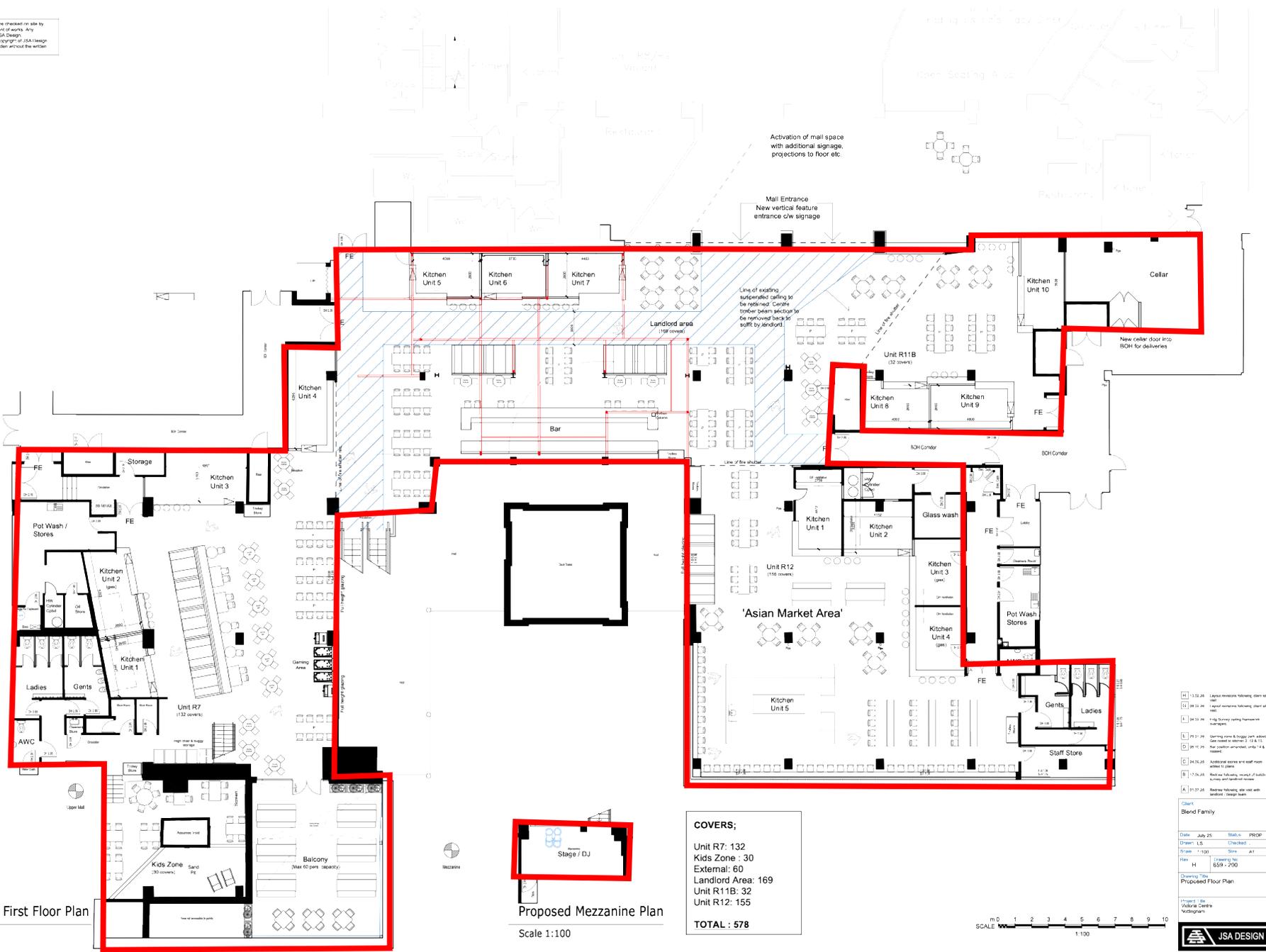
