The premises operate as a Papa John's pizza takeaway and delivery store. The business prepares and sells pizzas, sides, desserts and soft drinks for collection, takeaway and home delivery. The premises comprise a customer reception and ordering area, food preparation and kitchen facilities, storage areas, staff welfare facilities and delivery dispatch areas. A significant proportion of trade is conducted through online ordering platforms and telephone orders, with deliveries made by employed and contracted delivery drivers. The premises are operated as a professionally managed national franchise with established operating procedures, staff training programmes, food hygiene controls and customer service standards. The application seeks authorisation for the provision of late-night refreshment to facilitate customer collections and home deliveries during the requested operating hours.

The premises will operate as a professionally managed takeaway and delivery business. The licence holder is committed to promoting all four licensing objectives through the following measures:

- A comprehensive CCTV system will be installed and maintained covering all public areas, entrances, exits and delivery dispatch areas, with recordings retained for a minimum of 30 days and made available to authorised officers upon request.
- Staff will receive training in licensing responsibilities, conflict management, customer service and safeguarding awareness.
- The premises will maintain incident and refusals records where appropriate.
- Adequate fire safety and health and safety procedures will be maintained, including clear emergency exits and staff training.

***Continued from previous page...***

- The premises will operate primarily as a takeaway and delivery business during late-night hours, reducing customer congregation.
- Clear signage will request customers and delivery drivers to respect local residents and leave the area quietly.
- Delivery drivers will be instructed not to cause nuisance, including unnecessary engine idling, excessive noise or obstruction of the highway.
- Litter generated by the business will be regularly monitored and removed from the immediate vicinity of the premises.
- No adult entertainment, gambling facilities, age-restricted films or similar activities will be provided at the premises.
- Children will be permitted on the premises only for the purpose of purchasing food and refreshments and will be expected to be supervised by a responsible adult where appropriate.

**b) The prevention of crime and disorder**

The premises will operate a comprehensive CCTV system covering all customer areas, entrances, exits and delivery dispatch areas. CCTV recordings will be retained for a minimum of 30 days and made available to the Police or authorised officers upon request.

All staff will receive appropriate training in their responsibilities under the Licensing Act 2003, including the prevention of crime and disorder, conflict management and dealing with anti-social behaviour.

An incident log will be maintained and made available for inspection by responsible authorities upon request. Any incidents of crime, disorder or anti-social behaviour will be reported to the Police where appropriate.

The premises will be managed by trained staff at all times whilst open to the public. Adequate internal and external lighting will be maintained to promote customer and staff safety.

The business operates primarily as a takeaway and delivery service during late-night hours, reducing the potential for customer congregation. Delivery drivers will be instructed to act responsibly and minimise any disturbance to neighbouring properties and the local community.

**c) Public safety**

The licence holder is committed to ensuring the safety of customers, staff and visitors at all times.

The premises will comply with all relevant fire safety, health and safety and food hygiene legislation. Fire detection and firefighting equipment will be regularly maintained and emergency exits will be kept clear and unobstructed at all times.

Staff will be trained in emergency procedures, accident reporting and safe working practices. A first aid kit will be available on the premises and accidents will be recorded in an accident log.

The premises will be maintained in a safe condition, with adequate lighting provided internally and externally where appropriate. Regular inspections will be carried out to identify and address any potential hazards.

Customer access and egress routes will be kept clear to ensure safe movement within and around the premises.

**d) The prevention of public nuisance**

The premises will operate primarily as a takeaway and delivery business during late-night hours. Management will take all reasonable steps to minimise any disturbance to local residents and neighbouring businesses.

Clear signage will be displayed requesting customers to leave the premises and surrounding area quietly and to respect

local residents.

Delivery drivers will be instructed not to cause nuisance through excessive noise, unnecessary engine idling, loud conversations, slamming vehicle doors or obstructing neighbouring properties.

The area immediately outside the premises will be monitored and kept free from litter associated with the business. Regular litter patrols will be undertaken where necessary.

No amplified music, live entertainment or external speakers will be provided at the premises.

Waste collection, deliveries and other servicing activities will be managed responsibly to minimise noise and disturbance to nearby residents.

**e) The protection of children from harm**

The premises operate as a family-friendly takeaway and delivery business. The licence holder is committed to protecting children from harm at all times.

No adult entertainment, sexual entertainment, gambling facilities, gaming machines, age-restricted films or any other activities that may give rise to concern in respect of children will be provided at the premises.

Children will only be present on the premises for the purpose of purchasing food and refreshments and will be expected to be supervised by a responsible adult where appropriate.

Staff will receive safeguarding awareness training and will report any concerns regarding the welfare of children to the appropriate authorities where necessary.

The premises will maintain a safe and well-managed environment for all customers, including children and young persons.

**Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:**

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
  - evidence of the applicant's own identity – such as a passport,
  - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

**Home Office online right to work checking service**

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;

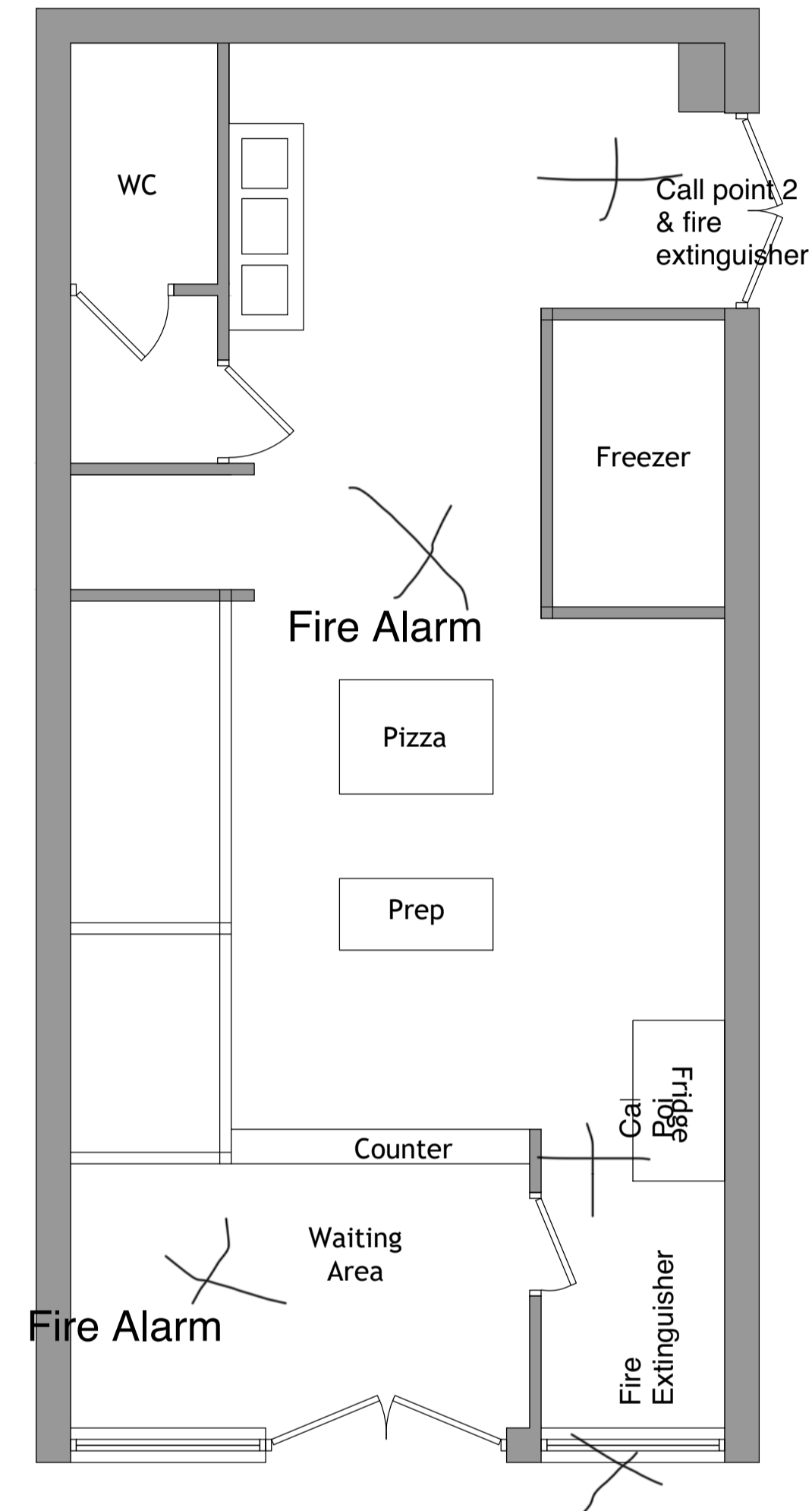

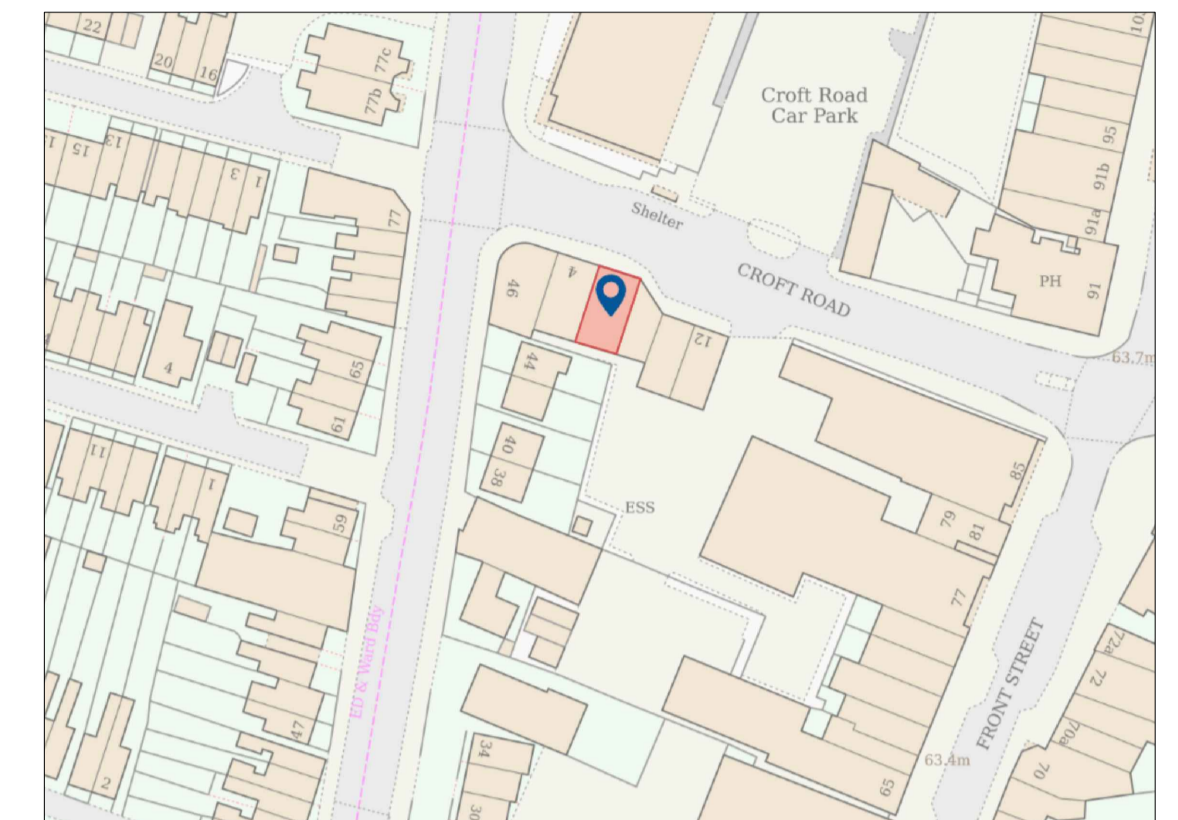

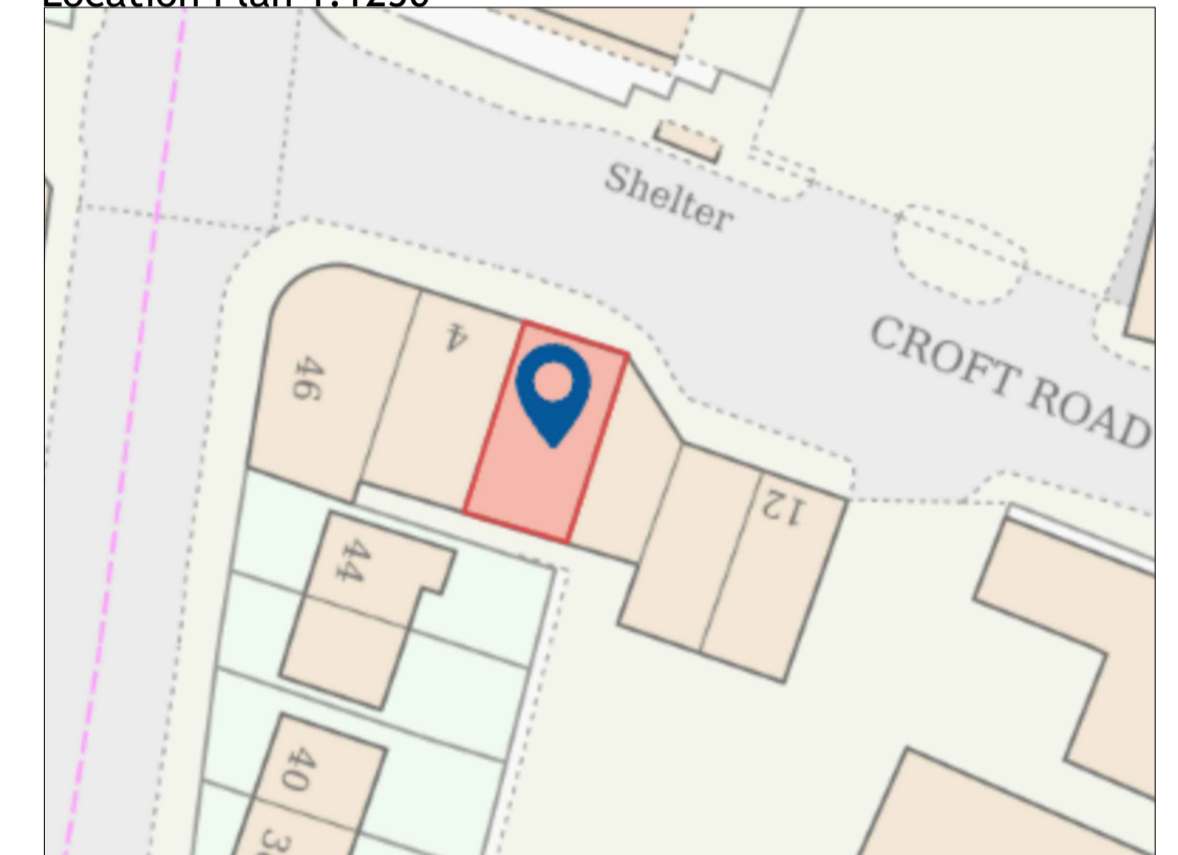

Ground Floor Layout 1.50

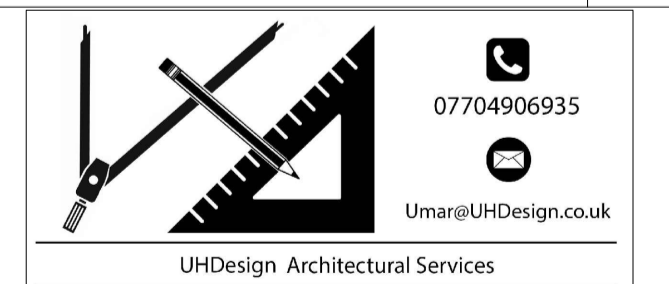


Location Plan 1.1250
