Our alcohol sales will be conducted online only.

Orders will be placed via our House of Harmony Shopify account.

We are also an approved supplier of alcohol to the trade ARWS No XDAW00000123430.

Our sales site will include statements & warnings concerning the consumption of alcohol in accordance with licencing objectives - b), c), d), and e).

b) The prevention of crime and disorder

All sales will be to valid account holders who have been verified via software embedded in our online store.

To purchase alcohol our from our online store will require that new customers register via an online approval process before they can open an account on our Shopify store to buy alcohol products from us.

There will also be a second layer of access for our approved by due diligence trade account holders in accordance with HMRC Excise Notice 2002.

c) Public safety

We shall not be selling directly to the consumer from Gothic House for consumption on or off the premises.

The sales route for alcohol from our premises will be via packed goods carried via approved carriers such as DHL who are approved to carry alcoholic goods.

There is no direct access to our office in Gothic House. Access to the offices in Gothic House is by keycode entry only while the main ground floor office is open. After 7:00pm the door also require a key to open the door.

d) The prevention of public nuisance

We are not selling directly to the public from Gothic House. Our wines will be exclusively collected using our DHL account PH0677, Ref L989839.



e) The protection of children from harm

The registration process will require the purchaser verify their age is over 18 to create an account. This process will be managed by embedded code within the Shopify application (Helium Customer Fields + liquid coding) along with the widely used Locksmith application. The Locksmith application is a software application that integrates with the Shopify software (Liquid & Helium Customer Fields to ensure there is no direct route for children to have direct access to our alcohol. On delivery the carrier will be requested where applicable to ask for ID to verify if the recipient is over the age of 18.

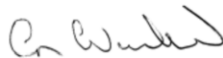
