# **DSL Network Aims and Purpose**



- ☐ To promote connectivity with the Nottingham City Safeguarding Children Partnership, other key local authority departments and Designated Safeguarding Leads across the city
- Act as a conduit for policy updates
- ☐ A network which demonstrates professional behaviours and mutual support
- ☐ Sharing of pertinent local and national updates focusing on safeguarding priorities and emerging trends across the city of Nottingham

### DSL Network process change- reminder

The Early Years team along with Nottingham City Safeguarding Children Partnership (NCSCP) have made the decision to discontinue issuing certificates as evidence of attendance at DSL Networks. This bring the PVI sector in-line with schools in Nottingham City.

Upon reviewing this process and considering the EYFS statutory guidance on DSL training expectations, which states that - 'The designated safeguarding lead (and any deputies) should undergo training to provide them with the knowledge and skills required to carry out the role. This training should be updated at least every two years'; we have concluded that the DSL Networks do not constitute formal training. **Therefore, we will no longer be issuing a DSL attendance certificates.** 

The DSL Networks, held once per term, aim to disseminate local updates, share knowledge, and discuss key safeguarding priorities at both local and national levels. While these networks are not formal training sessions, we hope they serve as valuable opportunities for safeguarding professionals to refresh their knowledge and skills, stay updated on relevant developments, and collaborate within a multiagency safeguarding environment.

In light of the above information the Early Years team are currently reviewing our CPD offer to DSL's. We encourage you to review your safeguarding training needs and speak to your support worker if you have any questions

# Aims of CADA ( Children Affected By Domestic Abuse )

#### Child health and wellbeing:

Increased wellbeing, reduced mental distress, improved sense of self and self-care and coping, enhanced social relations and social wellbeing

#### Feelings of safety:

Improved (understanding of) safety, CADA and non-abusing parents' increased understanding of abuse, freedom to go about daily life

#### Improved CADA access to support:

CADA have a voice, increased capacity to engage in school and social activities

equal relationships free from abuse

#### **Aims of CADA**

#### Early years professionals:

have increased understanding of and ability to identify and respond to DVSA/VAWG

#### Family relationships:

CADA and non-abusing parent have improved relationships, Caregiver emotional health and wellbeing improved, carers have greater understanding of abuse, parenting confident self-care and coping.



### Why is Domestic Abuse Training Important?

- The Domestic Abuse Act in 2021 introduced that children and young people are survivors of domestic abuse 'in their own right'.
- Historically, we believed that if babies, toddlers and young children 'don't see' incidents of DA

   they won't be impacted. However, we now know differently. Research tells us that babies
   and toddlers can be significantly impacted by Domestic abuse.
- Being able to identify, recognise and respond effectively to someone who discloses DA can help survivors of DA access specialist support.
- Agencies in Nottinghamshire are supporting child survivors of DA as young as 2 years old.
   We want you to know about them!

# **Local Statistics**

41% of adults disclosing via the CSEW reported children were present 46,500 Nottinghamshire residents are likely to have experienced DA in the last year

Children were likely to be present in 19,000 cases

Nottinghamshire Police recorded 4,236 DA crimes in 21/22 in which at least 1 child was present Nottinghamshire DA commissioned services supported 3,000 adults and 280 CYP experiencing DA in 2021

Non commissioning services supported another 300 CYP.

# NOTTINGHAM CITY Safeguarding Children PARTNERSHIP

#### National Audit on Group-based Child Sexual Exploitation and Abuse - GOV.UK

- commissioned by the Prime Minister and Home Secretary in February 2025
- led by Baroness Casey and carried out in March, April and May 2025.
- The report sets out how group-based CSE is defined in relation to child sexual exploitation and child sexual abuse, highlighting that:
  - child sexual abuse (CSA) is an umbrella term that includes different types of abuse, including intrafamilial CSA, online CSA and child sexual exploitation
  - child sexual exploitation (CSE) is a subset of child sexual abuse involving a power imbalance and the coercion or manipulation of a child into sexual activity in exchange for something the child needs or wants
  - group-based child sexual exploitation (group-based CSE) is a subset of child sexual exploitation where two or more perpetrators are involved.
- the 'grooming gangs' model of abuse is well documented and remains largely consistent, with the main difference in recent years being the growing role of online platforms and social media.
- all children are vulnerable because of their age, so they may not necessarily exhibit known risk factors and vulnerabilities

#### Recent Rapid Review Case Study



#### **Circumstances leading to rapid review:**

Baby A is a white British infant who lived with his mother. His early life was marked by both nurturing moments and significant risks. While he was seen to be clean, fed, and comforted by his parents, he was also exposed to conflict, shouting, and a chaotic home environment. His mother, a care leaver with a history of trauma and mental health challenges, and his father, who also experienced childhood adversity, struggled to consistently engage with support services. Baby A sustained a serious head injury, later confirmed as likely non-accidental, which was not immediately recognised or acted upon by professionals.

#### **Partnership Learning Points**

- Missed Opportunities for Early Intervention: Delayed antenatal engagement and lack of timely safeguarding referrals.
- Information Sharing Gaps: Critical safeguarding information was not accessed or shared across agencies.
- Professional Curiosity: Insufficient challenge and exploration of the causes behind Baby A's symptoms.
- Understanding Parental Vulnerabilities: The impact of trauma, mental health, and cognitive processing on parenting capacity was not fully considered.
