New Training Offer - Brilliant Babies!

With the early years entitlements now being offered to babies from 9 months old, there has been an increase in the number of babies accessing childcare provision and it has never been more important to ensure that the environment and curriculum for this unique age and stage is planned, understood and delivered appropriately and effectively. With this in mind, and in response to sector needs, we have developed 'Brilliant Babies', a two-part training programme to specifically support and extend the knowledge and understanding of practitioners working with the under twos. The course will run face to face at Castle Cavendish, 9.30am – 12.30pm on 12th February and 20th March 2025 at a cost of £50 for City Providers and £60 for Out of City Providers. Revision to Headcount Opening Date

We have been informed that the Capita system requires an update before sending out the Spring Term headcount and this applies to all Local Authorities. Childminder Start-up Grant Application Deadlines

New childminders wishing to apply for the Childminder Start-Up Grant will need to finalise their Ofsted or CMA registration by 31 March 2025. However, DfE recognises that in some circumstances childminder registration may be delayed due to registration checks taking longer than expected. For this reason, an applicant who submits their registration to Ofsted or a CMA by **3 January 2025** will still be eligible to apply for the grant if completion of their registration is delayed beyond 31 March 2025 for reasons relating to the completion of registration checks. In these cases, DfE will require Ofsted or CMAs to confirm that a registration has been delayed for these reasons. 
Future Communications from the Early Years Team

Help shape future early years projects funded by the Education Endowment Foundation

The Education Endowment Foundation has commissioned CooperGibson Research to explore the professional development and support programmes available to the early years sector in England. The research will provide information about the packages of support that setting staff are using to enable them to improve 2–5-year-old children's learning outcomes, and how these programmes relate to key thematic areas that could be included on the EEF's research agenda in future. The EEF are keen to get the best picture of the professional development and support programmes available to the sector, so if you have 10 minutes to complete the following survey before 20th December, it would be much appreciated! <u>Early years CPD survey</u>.

CSC Reform Practice Survey Now Live!

Working Together to Safeguard Children is the multi-agency statutory guidance that sets out expectations for the system that provides help, support and protection for children and their families, giving practitioners clarity about what is required of them individually and how they need to work in partnership with each other to deliver effective services. In December 2023 this guidance was updated with a focus on the following core themes: improved multi-agency working, a clear child-centred approach in working with children and their families, and decisive and effective multi-agency child protection response. There is now a review of these changes, and your feedback is being sought on the new principles for working with parents and carers, new multi-agency expectations, new national multi-agency child protection standards, and changes to section 17 including clarification that a broader range of practitioners can lead the direct work with children and their families. The aim of the survey is to develop an increased understanding of, and stronger evidence on, how Working Together 2023 is being implemented to inform future reviews of the guidance.
