Privacy Notice for contribution to CAMHS, SHARP, MHST Social Media

CAMHS – Child & Adolescent mental health service

SHARP – Self Harm Awareness &resources Project

MHST - Mental Health Support Team

We will use information provided by you. The basis under which the Council will be using personal data is for the purpose of consent.

The only data that will be requested is:

The child/young person's first name

- The child/young person's age (DOB)
- Your contact email address – so we can contact you in the future to gain feedback/ comments etc.
- A contact telephone number if this is preferred method of communication

Your first name and age will be displayed on Social Media, alongside your contribution.

If you are under the age of 14 years we will require parental consent. Please can parents email consent for your son/daughter's information to be posted on social media with their first name and age.

If your contribution is a video or you would like a picture of yourself displayed next to your artwork this would also require parental consent.

The information that you have provided will be kept until you turn 18 so that we can contact you, if necessary, in the future (unless you 'opt out' at a later date). Your contributions to social media will be kept indefinitely as Nottingham City Council will have these displayed on relevant social media platforms.

The new data protection law known as the General Data Protection Regulation provides for the following rights as prescribed by the legislation:

- A right to request a copy of your information
- A right to request rectification of inaccurate personal data
- A right to request erasure of your data known as ‘the right to be forgotten’
- A right to in certain circumstances to request restriction of processing
- A right in certain circumstances to request portability of your data to another provider
- A right to object to processing of data in certain circumstances
- A right regarding automated decision making including profiling
