The next deadline for funding applications to create new wraparound childcare places for primary school aged children or early years entitlement places for children under three is 27th February 2025. This was due to be our final funding round for this programme, however following confirmation of funding for 2025-26 for this programme, we are pleased to be able to **extend this funding** for further rounds in Summer 2025, Autumn 2025 and Spring 2026. Nottingham City Virtual School Early Years ePEP

It is statutory that those children attending a school nursery, childminder or PVI early years setting must have a PEP meeting every term and Nottingham City Virtual School now uses Welfare Call's electronic Personal Education Plan (ePEP) for all of Nottingham City's looked after children in early years provision. To support with the completion of the early years ePEP, the Virtual School has organised training for early years providers, social workers and other professionals to provide participants with knowledge and understanding of how the ePEP system works through a live demonstration of the ePEP system and considering professional's statutory responsibilities in respect to PEPs. The training, lead by Education Support Officer, Marcus Reid, is via MS Teams and is running on:

- Friday 16th May 2025, 9.30am 11.30am
