Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The premises will operate as a seated, 18+ cocktail bar with a strong emphasis on quality, service standards and responsible alcohol consumption. Alcohol will be served only to seated customers by trained staff, with table service throughout trading hours.

All staff will receive training on the licensing objectives, responsible alcohol retailing, refusal of service, and customer welfare. Free drinking water will be provided to all customers as standard with every drink order, and food snacks will be available to support responsible consumption.

Management will actively monitor customer behaviour and intervene early to prevent issues relating to intoxication, disorder, safety, nuisance or harm.

There will also be a cooling down period from last serving alcohol to closure, to ensure guests are hydrated and not forced out to prevent intoxication, disorder, safety, nuisance or harm.

A last entry time will be operated to prevent late-night surges of customers and to support orderly dispersal

b) The prevention of crime and disorder

The premises will operate as a calm, seated environment with no vertical drinking, reducing the likelihood of disorder. Alcohol will be served with an emphasis on quality and flavour rather than volume, and intoxicated persons will not be served.

A refusals log will be maintained and made available to authorised officers on request. Staff will be trained to identify signs of intoxication and to refuse service where appropriate.

CCTV will be installed and maintained in accordance with police recommendations, covering all public areas, with recordings retained for a minimum of 28 days and made available to the police or licensing authority upon request.

c) Public safety

Public safety is a key consideration in the operation of the premises. The venue will have a maximum capacity of 60 persons including staff in line with fire safety risk assessments. Seating will be arranged to ensure clear access to exits at all times.

All staff will receive training on emergency procedures, fire safety, and first aid awareness. The premises will be kept well-lit, clean and free from hazards.

As the premises is seated only, customer movement will be controlled, reducing risks associated with overcrowding or sudden surges in occupancy.

d) The prevention of public nuisance



The premises will operate as an intimate, sit-down cocktail bar with controlled background music played at a level that does not cause disturbance to neighbouring properties. There will be no live music or loud entertainment.

Staff will monitor customers leaving the premises and encourage them to do so quietly, particularly later in the evening. Clear signage will be displayed requesting patrons to respect local residents.

Waste and bottle disposal will not take place during late-night or early-morning hours. The management will regularly monitor the immediate external area to ensure it remains free from noise or disturbance associated with the premises.

e) The protection of children from harm

The premises will operate as an **18+ venue only**. No persons under the age of 18 will be permitted entry at any time.

A Challenge 25 policy will be implemented, with accepted forms of photographic ID limited to passports, photocard driving licences, or PASS-approved cards. Staff will be trained in age verification procedures and refusals will be recorded in a refusals log.

 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.



- a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

- 1) by providing with this application copies or scanned copies of the documents which an applicant may provide to demonstrate their entitlement to work in the UK (which does not need to be certified) that are published on GOV.UK and in guidance issued under section 182 of the Licensing Act 2003
- 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below)

Home Office online right to work checking service

As an alternative to providing a copy of the documents, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. We may otherwise share information with the home office. Your licence application will not be determined until you have complied with this guidance.

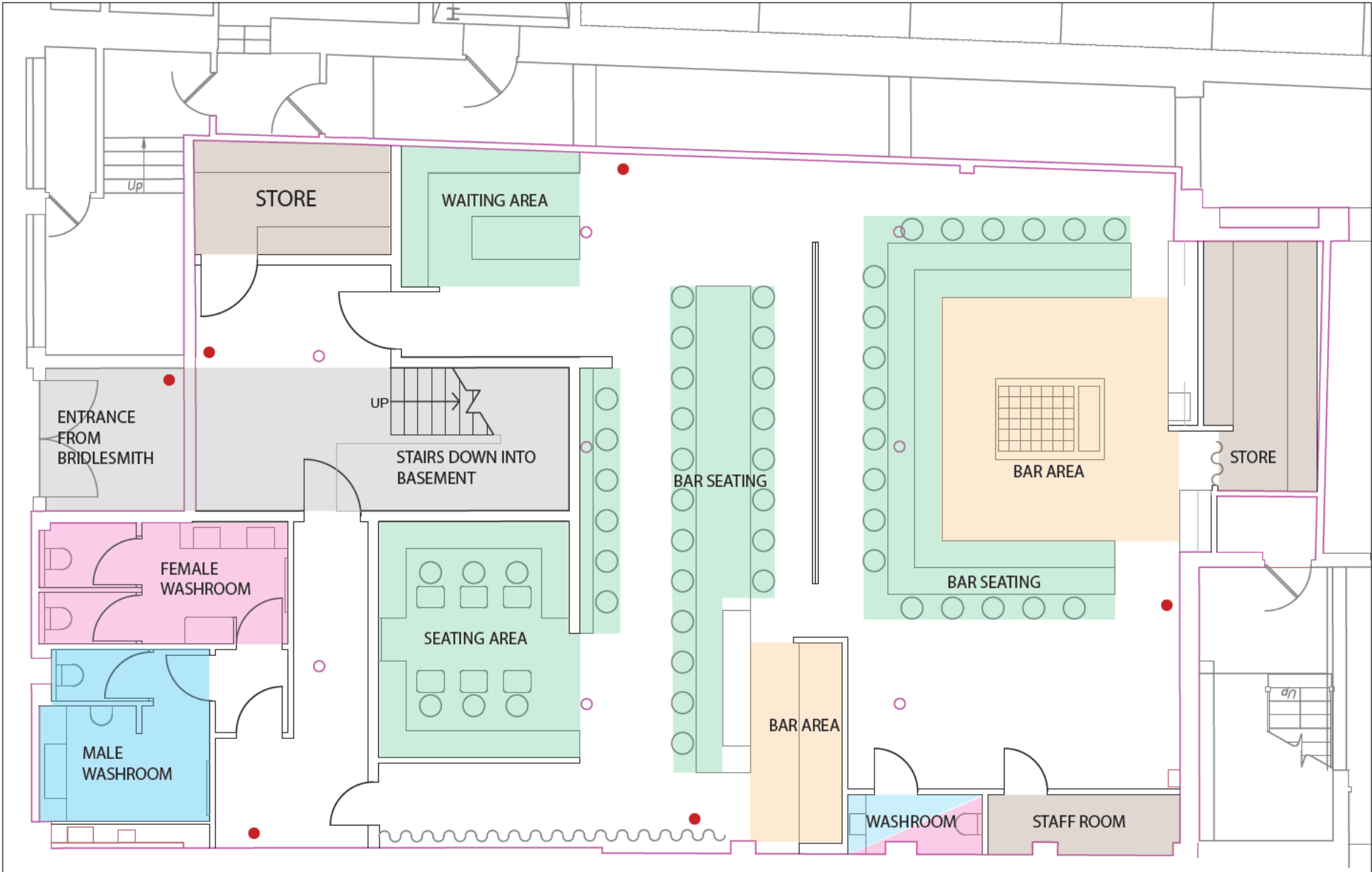

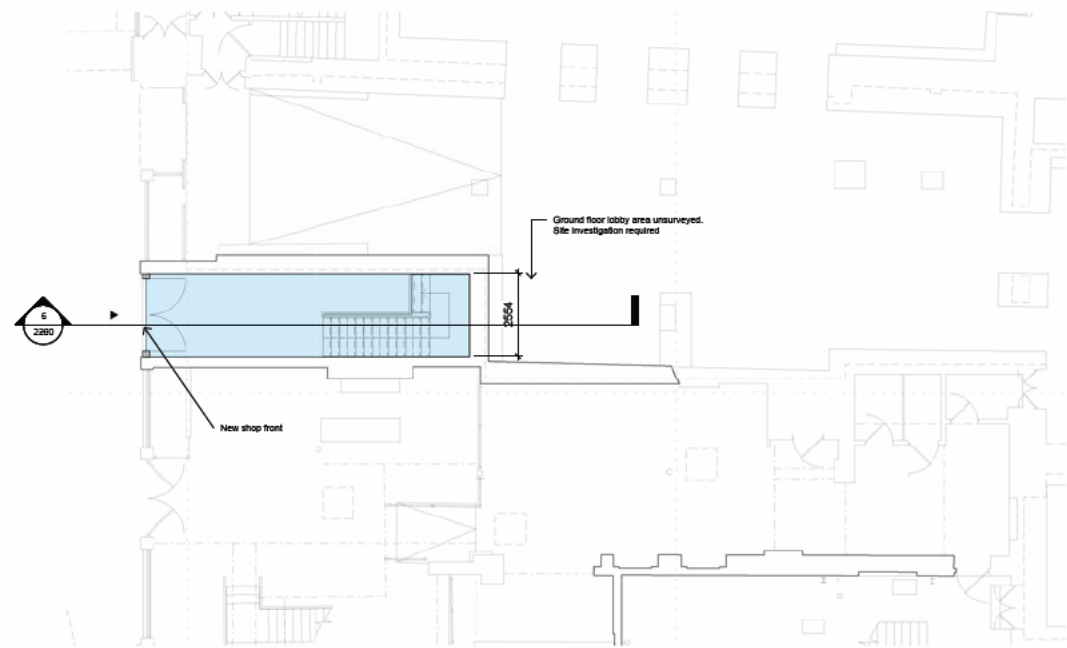

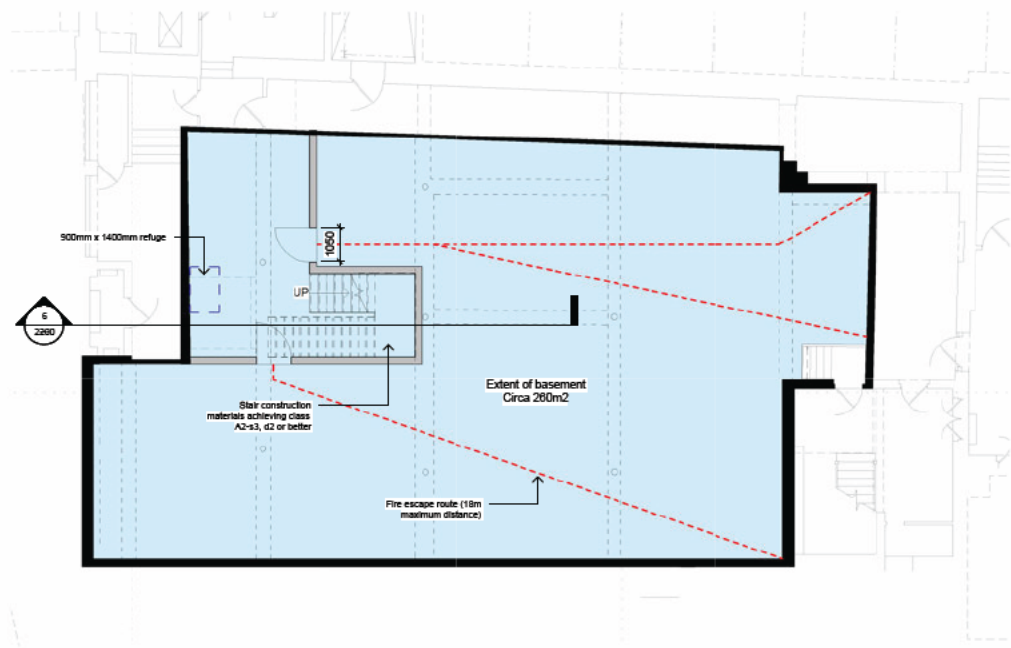


● Fire Extinguisher locations
